Many years ago, my oldest daughter (not Jenny) repeated something she had learned in school – “more hands lighten the work”. How true is that? If everyone pitched in and helped out, it wouldn't be such a burden for everyone.

When I look at the roster of the upcoming Convention, it floors me how many people have taken on two or three roles in order to put on our next convention. A few years ago, and not that long ago, all the chairperson positions were easily filled. Some dancers have served on the convention committee in some capacity or another for so long that they can't remember when they started!

There are so many people who won't join a club or the association because they don't want to work or bring refreshments, but they sure show up to dance and partake of the refreshments! Every time I hear “I'm not a joiner” or “If I join, you'll put me to work”, I think, “Well, I'm glad not everyone thinks that way or we wouldn't have dances to go to”.

All of these workers are getting up there in age and as their health declines or they pass away, there's no one there to pick up the reins.

We keep losing dancers! What's the solution? Have more classes, but the experienced dancers can't take the time to recruit new dancers or show up faithfully at the classes every week to angel and get to know the new dancers. Very rarely will new people show up at a dance or club if they don't know anyone. Experienced dancers need to get to the classes and get to know the new people so they will visit your clubs. I personally know a couple who have only been dancing four or five years who visited two or three dances in my area; they haven't gone back to two of them because people aren't very friendly. How many other people are out there that I haven't talked to that think the same thing?

“I don't like wearing square dance clothes.” Square dance attire is the uniform for our activity. Nurses wear a uniform, as well as law enforcement officers, airline employees, etc. Without saying a word, you are advertising our activity by being seen in our uniform. You will be surprised how many people will ask you about square dancing when they see someone wearing our “uniform”. If you go out to eat before a dance, wear your “uniform” when you go to the restaurant, or wear your “uniform” into the grocery store to pick up refreshments for the dance. I see medical people, Amazon delivery people, airline employees, law enforcement officers, etc. in the grocery store or the pharmacy all the time.

Yes, we have Florida state convention chairpersons lined up through 2025, but what's going to happen after that?
