President's Message

It is a beautiful sunny day as I sit here in my office writing this article for Bow and Swing. I hope that we all appreciate living here in Florida and that some (or most) of the square dance clubs are back in operation and that most of your dancers have returned to enjoy the fun and friendship with other dancers.

I am also hoping that you all have new beginner classes and that you have a good turn out for the lessons. Be sure to remind the new dancers how important it is that EVERYONE is gentle with the others you are dancing with. All to often the callers and other dancers become to involved with the learning of the rules of each move and forget to be gentle with others so as to not harm or hurt them with your hand grips and arm turns. We all need to use care so as to not squeeze to hard. You do not need a lot of pressure. Especially new dancers become unsure with what they are doing and start squeezing hard. Remember that lots of folks have arthritis and it hurts when someone hangs on, squeezes to hard or uses the wrong hold.

Remind the dancers that arm turns are forearms and not hand holds. (Unless they are using the hands up turns). A little instruction inserted into your patter calls with care can be a good reminder to all to be gentle with others.

I hope that you are all having good turnouts for your class. Treat the new dancers with gentle reminders of style and proper use of hands and arms is very important. Remember that the NEW dancers are the life blood of the Square Dance activity and keep them having fun and smiling.
