



Greetings from the WEST COAST of Florida!

The Tampa Bay area is bustling with dancing compared to the rest of our area on the west coast of Florida. Temple Twirlers of Tampa is dancing on the second and fourth Mondays and has two to four squares each night. Robert Arias is their club caller and Sandy Sturgis has started cueing for them.

Suncoast Squares in St. Pete dances twice a week every week with J.R. St. Jean calling. Their Monday night dance is Basic through Plus and Thursday night is Plus through Challenge. Occasionally, they have a Sunday afternoon dance with a guest caller.

Promenade Squares in Pinellas Park dances Mainstream / Plus every Friday night. They also have a new dancer class on Wednesday nights with excellent angel support, and they support Project Free which is a class for special needs adults.

Palace Promenaders dances Mainstream / Plus the first, third, and fifth Fridays in Arcadia. Robert Arias is their caller and they have recorded rounds by Judy Barnhill.

Citrus Squares in Inverness dances alternating class-level Mainstream / Plus every Monday night with Charlie Pergrossi.

Shufflin' Squares in Lake Wales dances Plus / Advanced the first and third Thursday, Mainstream / Plus the second, fourth, and fifth Thursday, and Advanced / Challenge every Sunday (if there are enough dancers). Keith Stevens and Dave Muller call for these dances.

There are only four classes at this time – Lakeland, St. Pete, Lake Wales, and Pinellas Park.

Considering that the West Coast Association covers 16 counties, this isn't very much square dance activity!

68th Florida State Square and Round Dance Convention

Mark your calendars now! You won't want to miss this one. The 68th Florida State Square and Round Dance Convention are January 20-21, 2023 at the Volusia County Fairgrounds in DeLand, Florida.

January 20-21, right in the middle of snowbird season! Everyone suggested we should have our convention during snowbird season so we will have better attendance.

Everything from the Trail-end Dance on Thursday night until the last square on Saturday night will be at the same location – the Volusia County Fairgrounds. There is an abundance of onsite camping as well as free parking. Make your camping reservations through the Fairgrounds office at 386-734-9514. Leave a message if no one answers the phone, it's a small two-person office.

There will be a disco-themed dinner dance on Friday evening at the Fairgrounds featuring the outstanding band "J and the 9s" performing LIVE disco music from the 70s and 80s including songs from Dance Fever, Grease, and Saturday Night Fever. Lead singer Jeanine Moss is an energetic and exciting singer/dancer along with her backup singers – they are sure to bring back memories of Olivia Newton-John and John Travolta. The menu is barbecue. You don't want to miss this fun evening—it's sure to be the highlight of this convention!!!

The host hotel, Courtyard by Marriott, is 5.7 miles (nine-minute drive) to the Fairgrounds. If the Courtyard is full, there are numerous hotels in the area.

From July 1, 2022 – November 30, 2022, the full weekend is \$45 per person and increases to \$50 from December 1, 2022, until the convention. The Weekender (Friday evening and all day Saturday) is \$32 per person until December 1, 2022, when it increases to \$35. The Weekender ribbons must be picked up at Registration.




